SPEAKING ORDER

Perused the Hon'ble Gauhati High Court's order dated 24-03-2023 passed in WP(C) No.1681/2023 (Kamini Kalita Vs. the State of Assam & 4 ors.) where the Hon'ble Gauhati High Court had directed the Director of Higher Education, Assam to "*do the needful following the relevant provisions and Rules as applicable and in force*".

Perused the Hon'ble Gauhati High Court's order dated 18-03-2024 passed in Cont. Case (C) No.147/2024 (Kamini Kalita Vs Dharma Kanta Mili, DHE, Assam).

Heard the Principal, Sapatgram College, Dhubri. However, the petitioner Sri Kamini Kalita was absent without citing any reason.

Perused the documents related to the selection process of Grade-IV of the College vide advertisement dated 14-06-2022, Corrigendum issued dated 10-11-2022, Call letter issued on 05-12-2022 and interview held on 13-12-2022.

Whereas, the petitioner had claimed that the issuing of the Corrigendum dated 10-11-2022 which altered the 'eligibility criteria' i.e., educational qualifications required to apply for Grade-IV post from HSLC passed to class 8(eight) pass was unjustified/illegal. However, the eligibility of class 8 (eight) pass for Grade-IV post is the right eligibility criteria as per existing rules which also has not affected the petitioner in any way for no new candidates submitted application after publication of the corrigendum.

Perused the documents related to the interview held on 13-12-2022 for the post of Grade-IV of Sapatgram College. According to the said documents the petitioner Kamini Kalita secured 26 marks with second position, whereas one Malobika Kalita secured 36.66 marks with first position. The petitioner's claim that he had secured more marks, hence does not hold.

Under the above circumstances the matter of Kamini Kalita is hereby disposed off.
